- 3. 2006 Southeast Sectional Indoor: Bids from Tri-State Archers, Tallahassee FL and Smokey Mountain Archers, Knoxville TN. Four votes for Florida (FL, GA, KY, SC). One vote for Tennessee (TN). The 2006 SE Indoor will be at the Tully Gym on FSU Campus on 11-12 March 2006 pending approval of the date by the Tully Gym in the fall. Host contact is Oliver Austin. Registration Chairman Tim Austin, FAA Sec/Treas.
- 4. 2006 Southeast Sectional Field: One bid from Gator Bowmen, Gainesville FL approved by the Directors. The 2006 SE Field will be at Gainesville on Memorial Day Weekend, 27-28 May 2006. Tim Austin, FAA Sec/Treas is host contact and registration chairman.
- 5. 2006 Southeast Sectional 3-D: One bid from Smokey Mountain Archers, Knoxville TN approved by the Directors. The 2006 SE 3-D will be at Smokey Mountain Archers on either 10-11 June or 24-25 June (alternate). Host contact, Gordon Oland, will verify date. He is contact for event.
- 6. Agenda Item SE-1 Florida will complete an agenda item requested by the President of the Crossbow organization to add equipment and shooting restrictions that were left out when last year's directors' meeting committee deleted the reference to crossbow organization rules. Tim Austin will submit. Approved.
- 7. Agenda Item SE-2 Florida will submit an agenda item to make Animal Group I distances in the Range Captain's Guide in the back of the rule book agree with the distances stated in the By-Laws. Approved

- 8. Agenda Item SE-3 Georgia submitted an agenda item to add FAX and E-Mail to methods of submitting agenda items to NFAA. Approved.
- 9. Agenda Item SE-4 Georgia submitted an agenda item to add FAX and E-Mail to methods of submitting Sectional Meeting agenda items to NFAA.
- 10. The Southeast Pro Representative shared the list provided by NFAA for Promembers in the Southeast. The list was inaccurate: It includes individuals who have not been NFAA members for as long as a year and includes individuals who have not paid Pro dues. It also does not include individuals who competed in the NFAA Indoor Nationals as Pros and thus must be current Pro Members. The Prorepresentative needs an accurate listing from NFAA that includes: a. A column listing the current NFAA Membership expiration date. b. A column listing the current Pro expiration date. And c. A column listing the shooting style for separation of pro money and points.
- 11. We need to share State Shooting Schedules between neighboring states. Shared shoot date information across state lines is needed to promote participation, especially with the constantly shrinking availability of Field Ranges.
- 12. The Councilman voiced an opinion for a critical need for archers to share in the workload of developing and MAINTAINING Field Archery Ranges. If you build and maintain the facility, archers will come and play. For every 20 who come and play, you may find one who is willing to help maintain the range.
- 13. RIC 2005-1 and 2005-2 were read at the meeting.
