Approximately 15% of the shooters at the 2006 Outdoor Nationals were free shooters. Our NFAA major events are one of our only sources of the income needed to provide service and benefits to our membership, and many of those events are operating at a loss. The free registration allowed by our constitution to older members has become a liability to our continued financial balance. A single older life member archer who attends all National and Sectional Events provided in one year without paying fees receives financial benefit equal to two thirds of the full adult life membership dues.

**RATIONALE:** (Describe briefly existing problem and expected benefit of proposed change)

An archer may choose to shoot in several Indoor and Outdoor Sectional tournaments of his choice, but only may compete for awards in that section of his residence.

Residence is determined by a declaration of the individual member. This allows archers to change their residence during the year so they can shoot the Indoor in one section and the Outdoor in a different section. As it is now, this must be done in writing to NFAA headquarters.

This restriction of written notification is unclear to most members and causes confusion at the sectional tournament when a member from outside the section attends and wants to shoot for an award.

NFAA membership cards are printed with "Indoor" "Outdoor" "3-D" at the bottom of the card, which can be X'd out or punched to indicate that the member has competed in that tournament for an award. Each section host should require that members show their membership card, then punch or X out that tournament. This will insure that each archer competes in only one sectional for awards.

10. Adjacent NFAA affiliated states shall be authorized to arrive at unilateral or reciprocal non-resident membership arrangements. Resident as being defined as from the state through which the member's NFAA card is drawn. NFAA members may join as many affiliated states, if accepted, as they wish. However, they may only shoot in the sectional and state championship of the resident state for championship awards. The member must notify NFAA Headquarters in writing when changing residence. NFAA members may compete for awards in only one Indoor, one Outdoor, and one 3D Sectional; and only one Indoor, one Outdoor, and one 3D State tournament per calendar year. **RATIONALE:** (Describe briefly existing problem and expected benefit of proposed change)

These tournament formats affect all NFAA members represented by the Board of Directors and not just the NFAA Council or Host Club that bid on the tournament. Changes to the tournament format and information put out for registration caused confusion within the membership and resulted in some members not attending the NFAA tournament in 2006. The benefit of adopting this would be a more informed Board of Directors on what is happening in the NFAA and they would be able to answer questions from the members when asked about registration, what format will be used and what days they can or have to shoot. In 2006, I had calls from members, not only in my state, but from other states because those directors were not kept informed of all the changes that were taking place for this three day tournament. I gave the answers to their questions as I was given from either headquarters or my councilman. However, two weeks before the tournament dates, I found out via the grapevine that the information I had given out was incorrect because it had been changed by headquarters and a selected few councilman at the last minute. I ended up calling the members that I had talked to before and giving them the quote "latest correct information on registration and days they could shoot". When I arrived at the tournament site, I found out that information had been changed again and members from my state again asked me why I had given out wrong information on shooting days.

By adopting this change, the Board of Directors should be kept informed and be able to have the correct information to give members prior to a major tournament because all changes would be set prior to information being put out by headquarters and published in the Archery magazine.

Old records will be revised to reflect the above record format and published to reflect the new 3 or 5 day tournaments which should be held in the future.

Secretary's note: Old records have not been eliminated. The Double Field and Double Hunter records are archived at headquarters. Prior records are based on Double Field round, Double Hunter round and Single Animal round. It is possible that the person who holds a record for a Double Field round is not the same person that would hold the record for the highest Single Field round. Example. Ben Hobbs holds the AMBHFS record for the highest Double Field round, set in 1997, however, it is possible that another archer in his division shot a single field round higher that one of Ben's score in that tournament. This could change many records, and because records have been based on double round scores, some single round scores from prior years may no longer be available. The record for a double hunter in the YMBB division was set in 1977. We no longer have the individual scores for 1977, so this could not be researched and changed.

Cost and number of awards at our tournaments are a concern. If we are not going to be concerned with the number of awards given, then the awards must be low in cost and similar for all... i.e. gold silver and bronze medals that cost such that even 100% awards will be covered by the registration fees. I do not think this is the direction we desire to go.

We need to have our adult (as opposed to all other age groupings from the youngest to the oldest) champion awards larger than all others... and yet, the most expensive awards (for financial viability) must not cost NFAA more than ½ of the adult registration fee. These guidelines work at club and state levels as well. If you want to give expensive prizes, then you have to charge expensive registration fees.

2007: Adult NFAA Champion Bowls (or other top individual event trophies or plaques) will be gauged to cost no more than one half of an adult registration fee. All other age divisions will receive smaller Champion Bowls (or other top individual event trophies or plaques), but of the same style and quality.
