2. The Treasurer's report was accepted as presented. CLOSED

3. **LONGBOW Competitive Division (2<sup>ND</sup> Reading):** Add, on a one year trial basis, a Longbow division (using IFAA equipment rules) to be available at FAA/NFAA shoots including 3-D. Unanimously approved. (Note: Will be in effect at 2003 shoots) CLOSED
4. **DOUBLE SCORE at Single Shoot Time (2<sup>nd</sup> Reading):** To allow an archer to shoot both rounds at one shooting time at both NFAA and NAA events in FAA competition by shooting both "A" and "B" lines at the same target butt. Where this registration is taken, two other archers must be grouped on the same butt. Unanimously approved. CLOSED
5. **PROTESTS:** The President moved to allow only protests from archers whose scores are directly effected by the protest. Seconded by NFAA Director. Yes: Northwest. No: North, Central, South, Past President, NFAA Director, and NAA Representative. Motion failed. CLOSED
6. **PROTESTS:** Northwest moved to raise the protest fee. Died for lack of a second. CLOSED
7. **PROTESTS:** Past President moved to lower the FAA Protest Fee to \$10. Seconded by NAA Representative. Yes: NFAA Director, Central, South, and NAA Representative. No: Northwest and North. Approved. OPEN FOR SECOND READING

8. **ALL DIRECTORS VOTING MEMBERS:** Secretary moved that all members of the FAA Board of Directors shall be voting members. Unanimously approved. OPEN FOR SECOND READING (The Board unanimous agreed to have this item take effect immediately.)
9. **UNMARKED 3-D 2003 DATE:** The unmarked 3-D Championship date for 2003 is moved from 9-10 August 2003 to 2-3 August 2003 at Central Florida Bowhunters in Ft Meade. Unanimously approved. CLOSED
10. **LET DOWN RULE:** Northwest moved and North seconded to delete Paragraph 18 (page 32) of the FAA Rulebook which outlines a special FAA Let Down Rule. Removal unanimously approved. OPEN FOR SECOND READING
11. **OFFICERS' BENEFIT:** South moved and Northwest seconded – At FAA Championships where officers pay a registration fee, they may pay only the host club portion of that fee. Unanimously approved. OPEN FOR SECOND READING
